However if you do not have such contact, you may get such recommendation cum guarantee from any other persons of repute. If your application is approved, you will have to get the attached both the guarantee papers franked in any of the banks before writing or signing them. After getting them franked the guarantee papers should be signed by respective persons and than submitted. As such do not send these guarantee papers along with the application.
4. On approval of your application you will be required to deposit with us in advance as many number of cheques as the number of instalments are agreed upon for the repayment of the loan. These cheques should not be deposited in loose forms. The original cheque book should be deposited.
5. Your application will be evaluated on the basis of the information given by you. When your application is approved and loan sanctioned, you will be informed about it over the telephone within 15 days. As such a telephone or a mobile contact of the applicant is a must. Enquiries about the fate of the application are not entertained nor the reasons for the rejection of the application given.

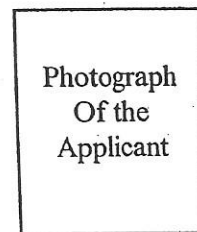
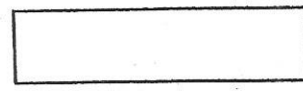
